Quientell introduced our speaker, Jennifer Moss, Assistant Curator/Education Specialist for the Oconee History Museum. She has worked for the museum for eight years.

The Oconee History Museum was founded as the Oconee Heritage Center about 15 years ago. There are programs for children and adults and is located at 123 John Brown Square in Walhalla.

She showed us a presentation called "To my Dearest" about William Lucius England, Jr. and his love letters.

William Lucius England was born 8 May 1896 in Westminster. SC. He attended Clemson College (University) in 1917 and was in Cadet Company I. He completed his degree at Clemson and completed military service. He taught Industrial Arts in Richmond. There are letters from 23 different women. The last letters were in 1920. Lucius never married. He died in 1967 in Richmond and is buried at the City Cemetery in Westminster.

Oconee Museum website includes maps of the area, Rockville, Illinois, and 1940 to 1953 maps as well as family forms. Also, she spoke about the General Store which is part of the museum.

19 Feb 1869, p. 2, col. 1. Change in advertisement on sale of personal property of M.F. Mitchell Bankrupt. The sale will take place on the 6<sup>th</sup>, instead of the 8<sup>th</sup> as advertised last week.

19 Feb 1869, p. 2, col. 1. Some items not readable. New brick plank kiln of Messrs. Biemann & Kaufman, destroyed by fire. (3,000 or 4,000 feet of lumber destroyed). Town needs fire engine.

19 Feb 1869, p. 2, col. 2. Death of Herman Heinrich Knee on February 11, 1869. Born in 1802 at Bochel, Kingdom of Hanover. At 18 he emigrated to London, England where he spent six years of his life. In 1824 he came to Charleston. In 1854 he moved to Walhalla, then a waste, and uninhabited, where he remained to the day of his death, filling in the New Settlement many positions of honor and trust.

19 Feb 1869, p. 2, col. 2. Tennessee River Railroad from Knoxville, TN to Anderson, SC.

19 Feb 1869, p. 2, col. 3. S.D.G. from Pickens, SC on 6 Feb 1869 for the Keowee Courier. Mr. Editor: As Oconee and Pickens Counties were formerly part and parcel of each other, it may not be uninteresting to the readers of the "Courier" in the former to hear something about citizens, &c., of the latter:

It is true that the beautiful Keowee rolls between the two Counties, but it does not present an impassable barrier, as was shown by the fact that Judge Wickliffe made his appearance in our new town on Tuesday last, notwithstanding the severity of storm and rain. The bridge, I learn, is still up near old Pickens C.H., and as long as it stands, we can hear from each other across the waters semi-occasionally.

New Pickens is making rapid strides, and soon we hope to see her the "Queen City" of the Mountains.

If fertility of soil, industry, energy and thrift can add to the wealth and population of this section, at no distant day we can confidently predict a bright future for this community.

The Court House is nearly completed, and when Messrs. Reid and Wilson puts on the finishing touch to the Court Room, the gay young gents of these parts intend to get up a magnificent Ball, and have a "nice time generally, on which interesting occasion it will be expected that Editors, Printers, and Devils in particular, will congregate. It will be a time long to be remembered, and will be the commencement of a new era in the history of our town [Pickens].

This is a healthy locality, but our resident physician, Dr. F.A. Miles, has plenty to do. Every now and then some one is bitten by a dog, or kicked by a horse, or meet up with some accident of some kind, which requires his attention. Then there are others who are troubled with the "Rumaty Pains," or a "mity hurtin' in the side," or the "tooth ache;" and some are afflicted "in the course of human events," all of which required medical aid.

The good people as yet have not been afflicted with but one lawyer, but others are coming, and then perhaps they will get each other by the cars, and then the dust must come.

Every one seems to be so good natured that it is almost impossible to get them to go to law. Compromise, compromise, is the word, and so say I, and nine times out of ten it is the best.

Our people should not forget the terrible ordeal through which we have passed. They should not forget the gallant dead, and the widows and orphans amongst us.

"Live and let live," and do not, oh! Yea, hardened usurer, demand the *pound of flesh* nearest the heart. Do not take the last morsel of bread out of the mouths of the innocent babes!

I am digressing. Come over and see our new town and judge for yourself. I am satisfied if you should come over and eat a good beef steak or mutton-chops with my hospitable friend, Hon. E.H. Griffin, you would return to Walhalla, with a flaming editorial of your visit, and do full and ample justice to all. Very respectfully, S.D.G.

# Application for Revolutionary War Pension South Carolina. Jeffrey Beck, Pickens District. Sled 16 May 1833 Sand reply to Col. I. Grisham, Falls Post Office, Pickens Cour

Filed 16 May 1833. Send reply to Col. J. Grisham, Falls Post Office, Pickens County, SC.

State of South Carolina. Pickens District. March Term 1833. On the seventh day of March 1833 personally appeared in Open Court before the Honorable Josiah J. Evans in the Court of General Sessions and Common Pleas of this the said State for the District aforesaid now sitting Jeoffrey Beck, a resident of the District of Pickens and State aforesaid, aged upward of eighty one years, who being first duly sworn according to Law, doth on his oath make the following declaration in order to obtained the benefit of the Act of Congress passed June 7, 1832.

That he entered the service of the United States under the following named officers and served as herein stated. That he turned out under Captain John Scotten of Col. Dugan's Regt. of the North Carolina Militia. He was sent out on a Scout with one Isaac McDaniel who was First Sergeant of the Company. He was engaged principally in the county he lived in, Randolph. He was sometimes in Chatham County, NC. He served a tour of nine months and was discharged by John Scotten the Captain on the 10<sup>th</sup> June 1779.



He was after called into service as a Volunteer in Capt. John Hinds? Company of Cavalry. He served three months as Ranger and was discharged on the 30<sup>th</sup> December 1780. He was engaged in several counties in N.C. adjoining Randolph where he lived, taking prisoners and keeping down the Tories. He was one of the first men called on to go to the South against the Tories and Cherokee Indians. He was unwell and unable to go. He hired Enoch Davis to go in his place and paid him Twenty-five dollars.

He took the Oath of Allegiance on the 12 Sep 1778. He lived on the main road and was liable to be much harassed; his Capt. John Hind gave him a \_\_\_\_\_ to protect his property while he was out or even at home against \_\_\_\_\_ by friends of the United States.

This declarant has no documentary evidence except such discharges and certificates as are herein mentioned and that he knows of no person whom testimony he can procure to testify to his services. This declarant was born in Augusta County, Virginia as he has understood. His Father \_\_\_\_ unto Orange County in the State of North Carolina which was afterwards divided and he was in Randolph and he was raised there and continued to live in that County till after the close of the Revolutionary War.



He moved into Pickens District about thirty two years ago, and has resided on the same plantation where he settled on coming from the State of North Carolina.

Sworn in Open Court. William L. Keith, C.C. John Cobb, a Clergyman, and Joseph Grisham swore they were well acquainted with Jeffrey Beck.

### Tombstone at Secona Baptist Church dedicated to Slave, Benjamin Griffin

On Saturday, May 16, 2019 at 4:00 p.m. local historians, friends, and relatives met at Secona Baptist Church Cemetery to dedicate a Confederate Marker to Benjamin Griffin, a Pickens County a former Slave. The ceremony was sponsored by Pickens County Historical Society, Faith Clayton Family Research Room and the James L. Orr UDC Chapter.

### 1914. A Brief Autobiography of An Ex-Slave

I was born 69 years ago on my master, Elihu Griffin's, plantation, four miles north of the present Pickens Court House. I have no recollection of my father. My mother, Tibitha, had eight children, one girl and seven boys, all of whom have passed into the boundless beyond, including my affectionate mother, save West Griffin and myself.

My boyhood days were spent in slavery. I was about 18 years old when freedom was proclaimed. In 1863 I was engaged in constructing fortifications and breastworks about Charleston and its suburbs. I saw many sharp skirmishes between the Union and the Confederate soldiers. I rejoice with the entire human family and this great republic that that sad and bitter period is past and only remembered by the necessity of

history. In 1865 when the Yankees came through here, I kept my master's mules, and hid with them in the woods off and on for about a month. I saved them every one. My mother kept my master's silver money during this time and saved it for him, and when the Yankees had gone she turned over every dollar to him.

April 2, 1867, I was married to Sarah T. Sizemore by Rev. B. Holder (white). There were 12 children to come to my home, eight of whom are now living.

In the fall, fourteen years after my marriage, a revival was in progress at Cold Spring, at which I was happily converted and immediately joined the Baptist church there. My membership now is at the Griffin Ebenezer Baptist church.

God has wonderfully blessed me with a powerful constitution. If it has been injured, I confess that I am the sole cause from my free use of bad whiskey, but through God's grace, I have sworn off.

I have endeavored in my private and public way to be a useful man to my race, the white people, and my country. Thru my indefatigable efforts I organized the first colored Free and Accepted Masons at Pickens C.H. Four years ago I organized the ex-Slave Reunion and have been its worthy president for three years. I was at the head of the movement to obtain land to inter our dead. Through that means the colored folks have two acres at Secona.

I have the greatest respect for my former master's relatives and the white people. They have been kind, generous and helpful to me. I have no malice nor hatred in my heart for or against anybody, white or black. I know I am saying a great deal, but I claim to be a true and honest Christian man, and only such any one can say and mean such. I trust, therefore, all men who read this, whose life is not in accord with the teachings of the whole Bible, will become as I profess to be, a Christian. "Dr." B. P. Griffin (*The Pickens Sentinel*, 12 Feb 1914, p. 2)

### 1925. "Dr." Ben Griffin Died Last Week

"Doctor" Ben Griffin, one of Pickens county's oldest, and best known colored citizens, died early Wednesday morning, April 22 at his home in Pickens after an illness of pneumonia which lasted only a week.

"Doctor Ben" was 80 years old and a veteran of the Civil War, having assisted in building fortifications, breastworks, etc. He was born in slavery in Pickens County on the plantation of Captain Griffin near Pickens town. He got his title of "doctor" from being an amateur veterinarian.

He delighted in telling his life story, of how he got the wicked ways of his youth, joined the church, and became a Christian. He was a good man and one thing he did is worthy of note. He used to tell it himself. From early manhood to late in life he was a constant and heavy drinker. But it is a fact that when he was an old man he quit that habit of a life time and quit it all at once, and his last years were spent in peace and perfect sobriety. And he gave all the credit to the Lord.

Dr. Griffin was married in 1867 to Sarah Thenia Sizemore, Rev. B. Holder performing the ceremony. Twelve children were born to them of whom six are living and six dead.

The deceased was a member of Griffin Ebenezer Baptist Church, [and] was prominent in colored fraternal organizations. The body was interred in the colored burying grounds at Secona church last Thursday.
